

**Goldman Sachs Nasdaq-100 Premium Income ETF (CUSIP#38149W630)
Goldman Sachs S&P 500 Premium Income ETF (CUSIP#38149W622)**

Notification of Source of Distributions

Pursuant to Rule 19a-1 under the Investment Company Act of 1940

The Goldman Sachs Nasdaq-100 Premium Income ETF (GPIQ) and the Goldman Sachs S&P 500 Premium Income ETF (GPIX) (collectively the “Funds”) declared a dividend of \$0.46550 per share and \$0.37627 per share, payable on February 6, 2026, to shareholders of record on February 2, 2026.

The Funds’ monthly distributions normally consist of net investment income and short-term capital gains. These are generally considered ordinary income for federal tax purposes. Because the Fund seeks to provide monthly distributions at a relatively stable rate, shareholders may receive distributions in excess of taxable income which constitute a return of capital for tax purposes.

As noted in the table provided below, the Funds made distributions during the fiscal year for which a portion is estimated to be in excess of the Funds’ taxable income. As of January 31, 2026, the estimated sources of these distributions were as follows:
