Fund Overview

The Goldman Sachs Multi-Strategy Alternatives Fund seeks long-term growth of capital. The Fund aims to generate differentiated returns by investing in asset classes with historically limited long-term sensitivity to traditional assets such as equities, potentially serving as part of a traditional multi-asset portfolio, as an uncorrelated source of return, or part of alternative investment allocations that focus on systematic macro-driven strategies.

Fund Performance and Market Highlights

Global equities gained over Q4. In the US, the S&P 500 grew by 2.07%. Most sectors gained, with Consumer Discretionary, Communication Services, and Financials rallying the most at 14.06%, 8.60%, and 6.67% respectively. Small cap performance rose slightly, with the Russell 2000 gaining 0.01%.

European markets saw slight losses over the quarter. Europe's STOXX 50 returned -2.09%, while UK stocks posted losses as the FTSE 100 returned -0.78%. In Japan, the TOPIX grew by 5.21%. Similarly, Asia ex-Japan equities showed losses in December over tariff concerns. For emerging markets such as China, Donald Trump's anticipated tariffs acted as a headwinds towards investment sentiment. With these concerns, the MSCI EM index drew down by -8.15%.

Treasury yields rose in most major economies. US 2Y yields rose 60bps, while US 10Y yields rose by 79bps. Internationally, Germany 2Y and 10Y yields rose by 1bps and 24bps respectively.

In FX, the US Dollar Index gained 7.65% in Q4, appreciating against most major currencies. Meanwhile, commodities gained, led by positive performance from livestock and energy, which were not fully offset by drawdowns from precious and industrial metals.

The Multi-Strategy Alternatives Fund ("MSA Fund") returned 0.81% (Institutional Share Class) net of fees during Q4. Over the quarter, fixed income contributed to performance, while commodities and currencies detracted from performance.

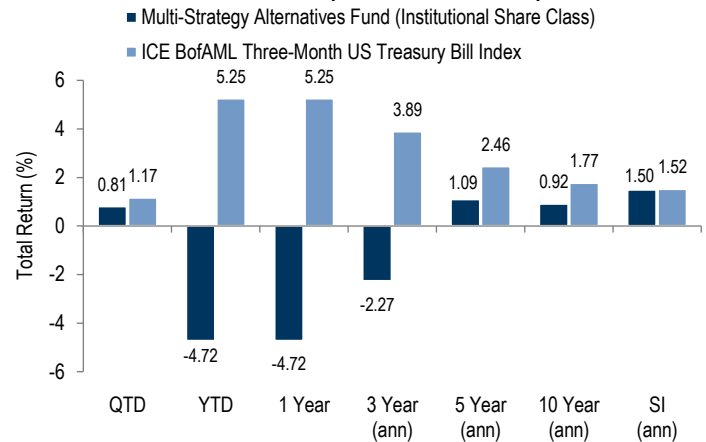
Contributors

Fixed income contributed to performance overall in Q4. Driven by increasing rates globally, short US 10 year treasury notes contributed notably. In Commodities, long positions in heating oil also contributed due to seasonality and speculation of shorter oil supply. Long Australian Dollar, primarily driven by the account surplus signal, contributed the most to the portfolio.

Detractors

Despite the positive contribution of long positions in heating oil, Commodities detracted overall in Q4. Short Cocoa detracted as the price rose over the quarter. Short Coffee also detracted, as the product increased in value. In Currencies, long Swedish Krona and Japanese Yen detracted notably as the dollar strengthened throughout the fourth quarter. In Fixed income, long 10 year JGB detracted as global rates rose.

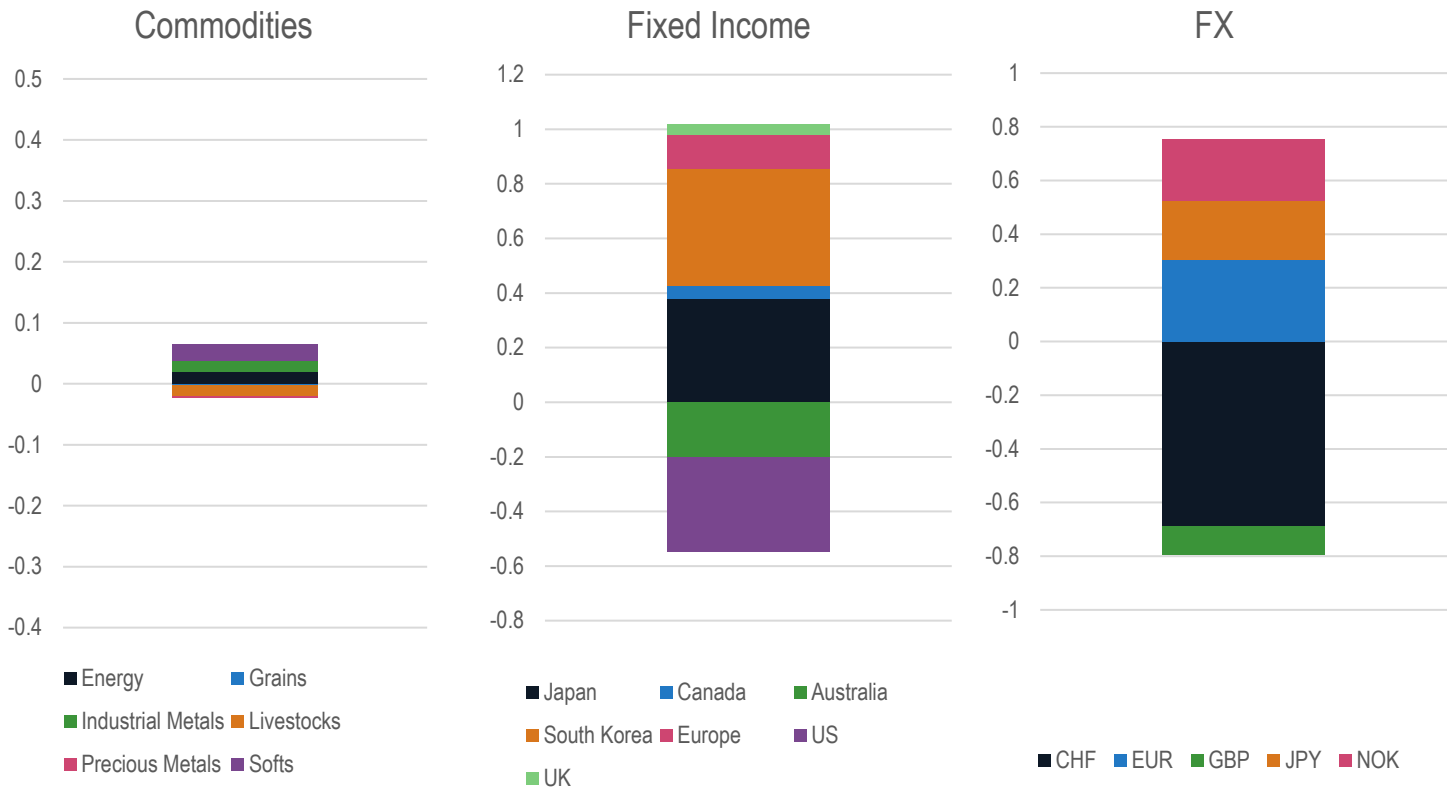

The tax treatment of the Fund's investments in the Subsidiary could affect whether income derived from such investments is "qualifying income" under Subchapter M of the Internal Revenue Code of 1986, as amended, or otherwise affect the character, timing and/or amount of the Fund's taxable income or any gains and distributions made by the Fund. The Fund invests in such instruments in reliance on an opinion of counsel.

The Fund may have a **high rate of portfolio turnover**, which involves correspondingly greater expenses which must be borne by the Fund, and is also likely to result in short-term capital gains taxable to shareholders. The Fund's **investments in other pooled investment vehicles** subject it to additional expenses.

**Key Terms**

**Correlation:** A statistical measure of the directional dependence between two variables. Correlation can fall between -1 and 1. A correlation of 1 implies that the two variables will move in the same direction, whereas a correlation of -1 indicates that two variables will move in opposite directions. A correlation of zero implies that the two variables move independently of each other.

**Duration-Adjusted:** Duration is a measure of sensitivity to a change in interest rates. We duration adjusted the Short-Term Interest Rate contracts to the respective 10-year government bond contract by multiplying the notional exposure of the Short-Term Interest Rate contract by the duration of the Short-Term Interest Rate contract divided by the duration of the 10-year reference contract of each respective country.

**Net exposure:** The sum of the total value of long and short exposures to that asset class. A strategy that is 30% long the S&P 500 and 25% short the Russell 2000 would have 5% net exposure to the US equity asset class. Net exposure is an indication of the Fund's directional exposure to each asset class. Fund returns are closely related to net exposure. The Net Exposure (%) figures presented in the Asset Class Composition Table on page 2 are the net exposures of the asset class as a percent of the total portfolio, 100%. The **total net exposure** figure is the sum of these asset class net exposures.

**Gross exposure:** The sum of the absolute value of long and short exposure within each asset class. For example, a strategy 30% long the S&P 500 and 25% short the Russell 2000 would have 55% gross exposure to equity. Gross exposure is an indication of the Fund's total use of capital and leverage.

**Total gross exposure:** The sum of the gross exposures of each asset class present in a portfolio.

**Shorts:** Positions in financial instruments in which the investor profits when the financial instrument declines in value.

**Longs:** Positions in financial instruments in which the investors profits when the financial instrument appreciates in value.

**Basis point:** 1/100<sup>th</sup> of a percent.

**Purchasing power parity:** is a measure of the price of specific goods in different countries and is used to compare the absolute purchasing power of the countries' currencies.
