Fund Overview

The Goldman Sachs Multi-Strategy Alternatives Fund seeks long-term growth of capital. The Fund aims to generate differentiated returns by investing in asset classes with historically limited long-term sensitivity to traditional assets such as equities, potentially serving as part of a traditional multi-asset portfolio, as an uncorrelated source of return, or part of alternative investment allocations that focus on systematic macro-driven strategies.

Fund Performance and Market Highlights

Global equities market continued their upward trend in Q3. In the US, the S&P 500 Index gained 5.53% amid strong corporate earnings and monetary policy easing. Gains were led by Utilities and Information Technology sectors, while the Energy sector lagged. European markets saw positive growth over the quarter. The EuroStoxx50 Index was up by 2.39%, and the German DAX Index grew by 5.97%. The blue-chip FTSE 100 Index also grew by 1.83%, echoing similar growth sentiments.

In Asia, the Japan TOPIX Index fell -4.90%, amid large fluctuations in Japanese equities and rising rates. Chinese market equities regained strength, with the HIS Index rising 21.67%, outperforming developed markets.

Treasury yields dropped across most countries. US 2Y yields fell by 107bps, and 10Y yields fell by 54 basis points (bps). Similarly, German 2Y yields were down by 76bps and 10Y yields were down by 36bps.

The US Dollar Index fell -4.81% in Q3, depreciating against most major currencies. The Malaysian Ringgit rose to its strongest level of the year, while the Yen rose too amid government rate hikes. Commodity prices fell, due to price drops in soybeans and heating oil, partly offset by coffee and gold.

The Multi-Strategy Alternatives Fund ("MSA Fund") returned 4.09% (Institutional Share Class) net of fees during August. Over the quarter, currencies and fixed income contributed to performance, while commodities detracted from performance.

Contributors

Currencies contributed to the performance overall in Q3. Driven by the Bank of Japan's hike on interest rates, the long Japanese Yen position was the largest contributor to the portfolio. In Fixed Income, long Japanese 10-year government bonds also contributed. Long British Pound, primarily driven by the account surplus signal, also posted notable contributions. In Commodities, long natural gas contributed slightly as well.

Detractors

Despite the positive contribution of long positions in natural gas, Commodities detracted overall in Q3. Short coffee detracted the most as its price jumped during the quarter. Short gold also detracted as the precious metal grew in value. The positions were mainly driven by our contrarian over-positioning signals. In Fixed Income, short US 10-year government bonds detracted the most as the fed reduced interest rates, driven by our account surplus signals. In currencies, short Australian Dollar and Swiss Franc detracted notably as the dollar weakened partially throughout the third quarter.



The Fund invests in such instruments in reliance on an opinion of counsel.

Key Terms

Correlation: A statistical measure of the directional dependence between two variables. Correlation can fall between -1 and 1. A correlation of 1 implies that the two variables will move in the same direction, whereas a correlation of -1 indicates that two variables will move in opposite directions. A correlation of zero implies that the two variables move independently of each other.

Duration-Adjusted: Duration is a measure of sensitivity to a change in interest rates. We duration adjusted the Short-Term Interest Rate contracts to the respective 10-year government bond contract by multiplying the notional exposure of the Short-Term Interest Rate contract by the duration of the Short-Term Interest Rate contract divided by the duration of the 10-year reference contract of each respective country.

Net exposure: The sum of the total value of long and short exposures to that asset class. A strategy that is 30% long the S&P 500 and 25% short the Russell 2000 would have 5% net exposure to the US equity asset class. Net exposure is an indication of the Fund's directional exposure to each asset class. Fund returns are closely related to net exposure. The Net Exposure (%) figures presented in the Asset Class Composition Table on page 2 are the net exposures of the asset class as a percent of the total portfolio, 100%. The **total net exposure** figure is the sum of these asset class net exposures.

Gross exposure: The sum of the absolute value of long and short exposure within each asset class. For example, a strategy 30% long the S&P 500 and 25% short the Russell 2000 would have 55% gross exposure to equity. Gross exposure is an indication of the Fund's total use of capital and leverage.

Total gross exposure: The sum of the gross exposures of each asset class present in a portfolio.

Shorts: Positions in financial instruments in which the investor profits when the financial instrument declines in value.

Longs: Positions in financial instruments in which the investors profits when the financial instrument appreciates in value.

Basis point: 1/100th of a percent.

Purchasing power parity: is a measure of the price of specific goods in different countries and is used to compare the absolute purchasing power of the countries' currencies
