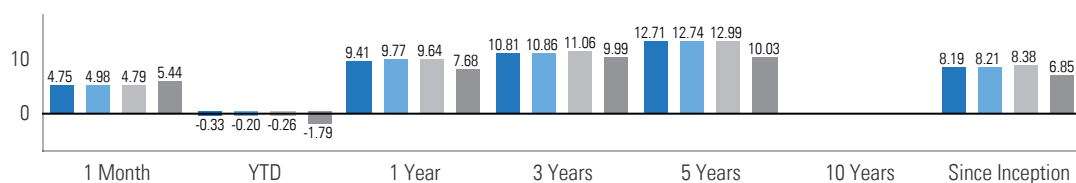

The NAV used in the Total Return calculation assumes all management fees and operating expenses incurred by the Fund. The first day of secondary market trading is typically several days after the fund inception of investment operations date; therefore, the NAV of the Fund is used as a proxy for the period from inception of investment operations to the first day of secondary market trading to calculate the Market Price returns.

Under the management agreement for Goldman Sachs ActiveBeta-U.S. Small Cap Equity ETF (the "Fund"), Goldman Sachs Asset Management, L.P. Net Asset Value is the market value of one share of the Fund. Market Price is the price at which the Fund's shares are trading on the NYSE Arca. The Market Price of the Fund's shares will fluctuate and, at the time of sale, shares may be worth more or less than the original investment or the Fund's then current net asset value. The Fund cannot predict whether its shares will trade at, above or below net asset value. The Goldman Sachs ActiveBeta® U.S. Small Cap Equity Index (the "Index") is designed to deliver exposure to equity securities of small capitalization U.S. issuers. The Index seeks to capture common sources of active equity returns, including value (i.e., how attractively a stock is priced relative to its "fundamentals", such as book value or free cash flow), momentum (i.e., whether a company's share price is trending up or down), quality (i.e., profitability) and low volatility (i.e., a relatively low degree of fluctuation in a company's share price over time). To construct our ActiveBeta® Index we:

Start with the market capitalization weighted universe  
Score each stock in the universe on four distinct factors: Value, Momentum, Quality and Low Volatility  
Construct 4 factor indices by overweighting stocks with higher factor scores and underweighting or removing stocks with lower factor scores; constraining weights to remain broadly in line with the market  
Combine these 4 factor indices equally to form the ActiveBeta® Index  
Rebalance the ActiveBeta® Index quarterly, using a patent-pending technique to reduce turnover

The Goldman Sachs ActiveBeta® U.S. Small Cap Equity ETF (the “Fund”) seeks to provide investment results that closely correspond, before fees and expenses, to the performance of the Goldman Sachs ActiveBeta® U.S. Small Cap Equity Index (the “Index”), which delivers exposure to equity securities of small-capitalization U.S. issuers. The Fund’s investments are subject to **market risk**, which means that the value of the securities in which it invests may go up or down in response to the prospects of individual companies, particular sectors or governments and/or general economic conditions.
