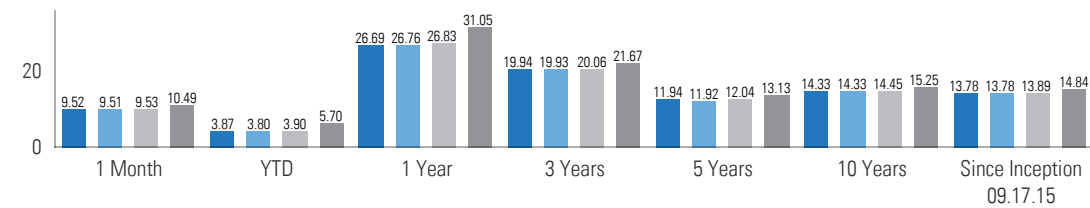

Combine these 4 factor indices equally to form the ActiveBeta® Index  
Rebalance the ActiveBeta® Index quarterly, using a patent-pending technique to reduce turnover

The Goldman Sachs ActiveBeta® U.S. Large Cap Equity ETF (the "Fund") seeks to provide investment results that closely correspond, before fees and expenses, to the performance of the Goldman Sachs ActiveBeta® U.S. Large Cap Equity Index (the "Index"), which delivers exposure to equity securities of large-capitalization U.S. issuers. The Fund's investments are subject to **market risk**, which means that the value of the securities in which it invests may go up or down in response to the prospects of individual companies, particular sectors or governments and/or general economic conditions. Because the Fund may **concentrate its investments** in an industry or group of industries to the extent that the Index is concentrated, the Fund may be subject to greater risk of loss as a result of adverse economic, business or other developments affecting that industry or group of industries. **Investment terms:** The **Price to Book (P/B)** ratio is used to compare a stock's book value to its market value. It can be aggregated for groups of stocks. It can be aggregated for groups of stocks. **Return on Equity (ROE)** is the amount of net income as a percentage of shareholders equity. **#Dividend Yield** is derived as a weighted average of the dividend yield of the underlying securities and is not a distribution payment made by the fund.
