Fund Overview

The Goldman Sachs Multi-Strategy Alternatives Fund seeks long-term growth of capital. The Fund aims to generate differentiated returns by investing in asset classes with historically limited long-term sensitivity to traditional assets such as equities, potentially serving as part of a traditional multi-asset portfolio, as an uncorrelated source of return, or part of alternative investment allocations that focus on systematic macro-driven strategies.

Fund Performance and Market Highlights

Global equities were mixed over the first quarter of 2025. In the US, the S&P 500 fell by -4.59%. Most sectors gained, with Energy and Health Care rallying the most at 9.30% and 6.08% respectively. Info Tech and Consumer Discretionary performed worst over the quarter, losing -12.79% and -13.97%, respectively. Small cap performance fell, with the Russell 2000 losing -9.79%.

European markets saw gains over the quarter. Europe's STOXX 50 returned 7.20%, while UK stocks posted gains as the FTSE 100 returned 5.01%. In Japan, the TOPIX fell by -4.53%. Asia ex-Japan equities posted modest gains in the first quarter. For emerging markets, the MSCI EM index grew by 2.93% on the back of a weaker US dollar and falling US treasury yields.

Treasury yields were mixed among major economies. The US 2-Year yield fell by 11 bps, while the US 10-Year yield fell by 3 bps. Internationally, German 2-Year and 10-Year yields increased by 2 bps and 33 bps respectively, following a push for military growth by European economies.

Regarding FX, the US Dollar Index fell -3.94% in the first quarter, depreciating against most major currencies. Meanwhile, commodities gained, led by positive performance from precious metals and livestock, although partially offset by drawdowns from agriculture.

The Multi-Strategy Alternatives Fund ("MSA Fund") returned 5.47% (Institutional Share Class) net of fees during Q1 2025. Over the quarter, currencies contributed to performance, while commodities and fixed income detracted from performance.

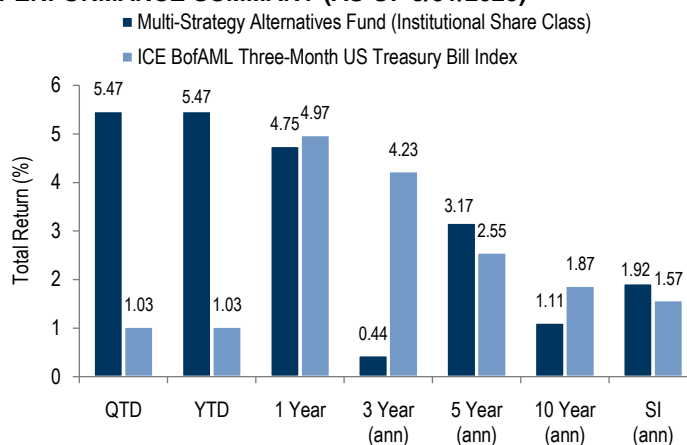
Contributors

Currencies contributed to performance overall in the first quarter. Driven by a weakening dollar, long forwards on developed market currencies contributed, namely being long the Norwegian Krone and Swedish Krona. Within Commodities, long positions in natural gas and copper also contributed. Within Fixed Income, long positions in Korean bonds contributed.

Detractors

Despite the positive contribution of long positions in Korean bonds, Fixed Income detracted overall in the first quarter. Short 10-Year T-Notes detracted, followed by long Japanese bonds. Within Commodities, short coffee and short gold positions detracted as prices rose. Within Currencies, being short the Swiss Franc and British Pound detracted, as they rose in value.

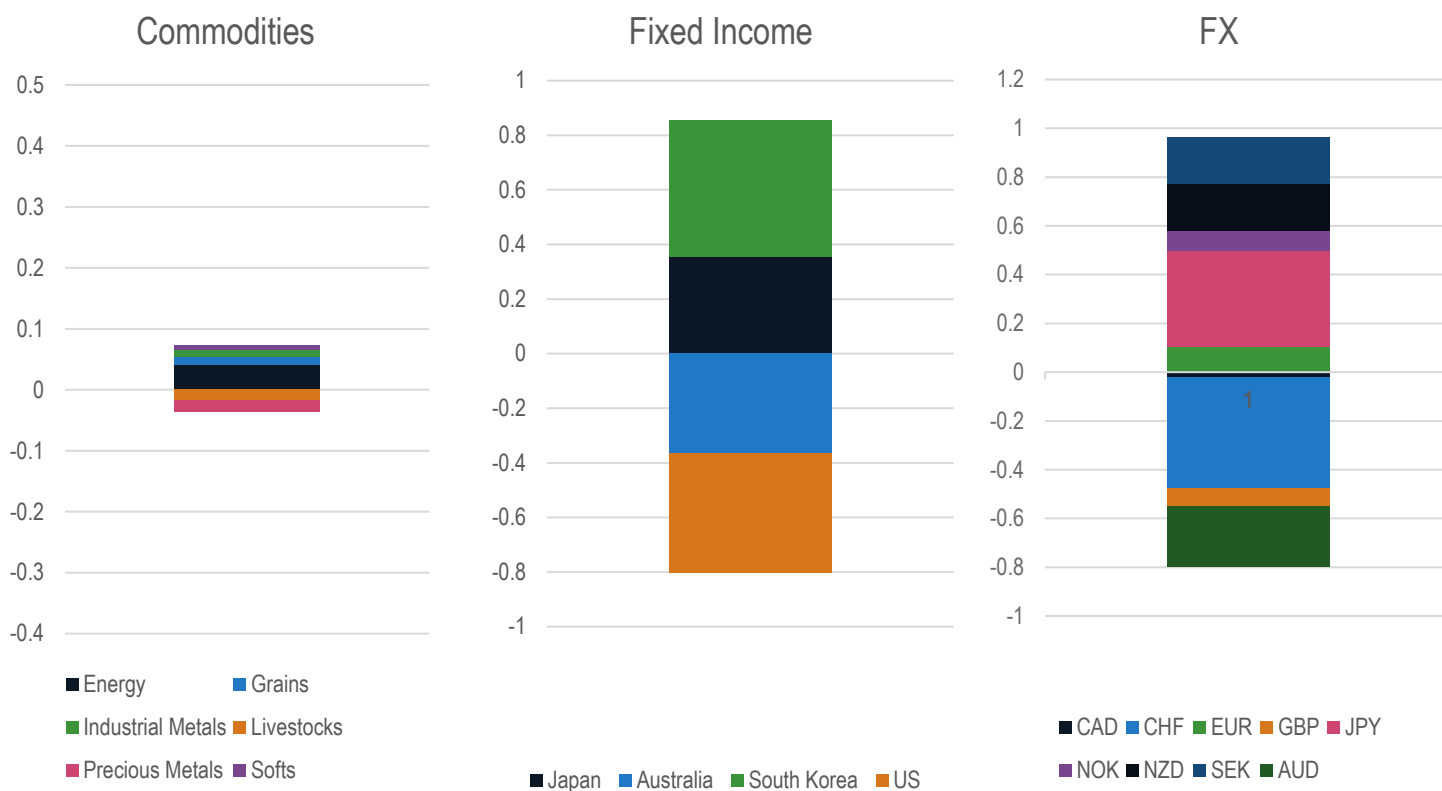

The Fund is subject to the risk that exposure to the **commodities markets** may subject the Fund to greater volatility than investments in traditional securities. The Fund is subject to **tax risk** as a result of its investments in the Subsidiary. The tax treatment of the Fund's investments in the Subsidiary could affect whether income derived from such investments is "qualifying income" under Subchapter M of the Internal Revenue Code of 1986, as amended, or otherwise affect the character, timing and/or amount of the Fund's taxable income or any gains and distributions made by the Fund. The Fund invests in such instruments in reliance on an opinion of counsel.

The Fund may have a **high rate of portfolio turnover**, which involves correspondingly greater expenses which must be borne by the Fund, and is also likely to result in short-term capital gains taxable to shareholders. The Fund's **investments in other pooled investment vehicles** subject it to additional expenses.

The Investment Adviser may determine to allocate the Fund's assets to all or a subset of the non-traditional and alternative strategies at any one time, and may change those allocations from time to time in its sole discretion and without prior notice to shareholders.

Key Terms

Correlation: A statistical measure of the directional dependence between two variables. Correlation can fall between -1 and 1. A correlation of 1 implies that the two variables will move in the same direction, whereas a correlation of -1 indicates that two variables will move in opposite directions. A correlation of zero implies that the two variables move independently of each other.

Duration-Adjusted: Duration is a measure of sensitivity to a change in interest rates. We duration adjusted the Short-Term Interest Rate contracts to the respective 10-year government bond contract by multiplying the notional exposure of the Short-Term Interest Rate contract by the duration of the Short-Term Interest Rate contract divided by the duration of the 10-year reference contract of each respective country.

Net exposure: The sum of the total value of long and short exposures to that asset class. A strategy that is 30% long the S&P 500 and 25% short the Russell 2000 would have 5% net exposure to the US equity asset class. Net exposure is an indication of the Fund's directional exposure to each asset class. Fund returns are closely related to net exposure. The Net Exposure (%) figures presented in the Asset Class Composition Table on page 2 are the net exposures of the asset class as a percent of the total portfolio, 100%. The **total net exposure** figure is the sum of these asset class net exposures.

Gross exposure: The sum of the absolute value of long and short exposure within each asset class. For example, a strategy 30% long the S&P 500 and 25% short the Russell 2000 would have 55% gross exposure to equity. Gross exposure is an indication of the Fund's total use of capital and leverage.

Total gross exposure: The sum of the gross exposures of each asset class present in a portfolio.

Shorts: Positions in financial instruments in which the investor profits when the financial instrument declines in value.

Longs: Positions in financial instruments in which the investors profits when the financial instrument appreciates in value.

Basis point: 1/100th of a percent.

Purchasing power parity: is a measure of the price of specific goods in different countries and is used to compare the absolute purchasing power of the countries' currencies.
