





Glossary

- Excess returns— The return of the fund in excess of the benchmark/index return (annualised).
- **Historical Volatility of Portfolio** Illustrates the dispersion of the fund's realized monthly returns around the average monthly return, indicating how volatile the fund's return is over time. The higher the number the more volatile the fund's returns.
- Net Asset Value

 Represents the net assets of the fund (ex-dividend) divided by the total number of shares issued by the fund.
