## What is this product ?

### Type

ING Direct is an undertaking for collective investment organized under the laws of Luxembourg as a société d'investissement à capital variable (S.I.C.A.V.) and qualifies as a UCITS. ING Direct is registered pursuant to Part I of the Law of 17 December 2010 and is established as an "umbrella structure" comprised of a number of sub-funds. You are purchasing a class of shares in the sub-fund.

### Term

The term of the Fund is unlimited and therefore there is no maturity date. The Manufacturer may not unilaterally terminate the Fund, however, the directors of the Fund and/or the investors of the Fund may in certain circumstances set out in the Prospectus and constitutive document of the Fund, unilaterally terminate the Fund. Cases of automatic termination may be foreseen by laws and regulations applicable to the Fund.

### Objectives

The Fund is classified as a financial product under Article 8 of the EU Sustainable Finance Disclosure Regulation. The Fund promotes environmental or social characteristics but does not have sustainable investments as its objective. The Fund integrates ESG factors and risk in the investment process alongside traditional factors. The fund qualifies as a feeder fund, meaning that the fund invests at least 85% of its assets in Amundi Funds Emerging Markets Blended Bond (the master fund). The residual assets of the fund (up to 15%) are exclusively invested in ancillary liquid assets (e.g. money market instruments) or held as cash, as may be required from time to time for dealing, for liquidity purposes and the payment of costs and expenses of the fund. The fund has the same investment objectives and policy as the master fund. However, the performance of both the fund and the master fund may not be equal due, in particular, to costs and expenses incurred by the fund and residual assets investments. The objective of the master fund is to outperform the reference indicator composed to 50% of 'JP Morgan EMBI Global Diversified Euro Hedged' index and to 50% of 'JP Morgan ELMi+' index (denominated in local currencies and converted in EUR) over an investment horizon of at least three years after taking into account charges. To achieve that objective, the master fund invests at least 50% of its net assets in debt instruments issued or guaranteed by governments or government agencies of developing countries or issued by corporate issuers of developing countries. The master fund may also invest in financial instruments whose value and income payments are derived from and collateralized (or "backed") by a specified pool of underlying assets ('asset-backed securities'). The use of financial derivatives instruments will be an integral part of the investment policy for arbitraging, hedging against and/or overexposing to risks of interest rates, credit and volatility. Currency derivatives will exclusively be used for hedging purposes. The combination of 50% of 'JP Morgan EMBI Global Diversified Euro Hedged' index and to 50% of 'JP Morgan ELMi+ (EUR)' index represents the reference indicator of the master fund. However, the master fund does not aim to replicate the reference indicator and may therefore significantly deviate from it. You can sell or buy your participation in this fund on each (working) day on which the value of the units is calculated, which for this fund occurs daily. The fund does not aim to provide you with a dividend. It will reinvest all earnings

The return of the Portfolio depends on the performance of the Portfolio, which is directly related to the performance of its investments. The risk and reward profile of the Portfolio described in this key information document assumes that you hold your investments in the Portfolio for at least the Recommended Holding Period as set out below under the heading "How long should I hold it and can I take money early out".

### Intended retail investor

Shares in the Portfolio are suitable for any investor (i) for whom an investment in the Fund does not constitute a complete investment program; (ii) who fully understands and is willing to assume that the Fund has a risk of 3 out of 7, which is a medium-low risk class ; (iii) who is neither a U.S. Person nor subscribing for Shares on behalf of one or more U.S. Persons; (iv) who understands that they may not recover any or all of the invested amount and can bear the loss of their entire investment; and (v) who are looking for medium term investment.

Under Luxembourg Law of 17 December 2010 on Undertakings for Collective investment sub-funds assets and liabilities of the sub-funds of the fund are segregated and may be deemed to be separate entities for the purpose of the relations between investors and may be separately liquidated.

## What are the risks and what could I get in return ?

- We have classified this Fund as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the Fund's capacity to pay you.
- The actual risk can vary significantly if you cash in at an early stage and you may get back less.
- You may not be able to cash in early. You may have to pay significant extra costs to cash in early.
- Be aware of currency risk when the currency of the Fund is different than the official currency of the Member State where the Fund is marketed to you. You will receive payments in a different currency than the official currency of the Member State where the Fund is marketed to you, so the final return you will get depends on the exchange rate between the two currencies. The risk is not considered in the indicator shown above.

## What happens if the Goldman Sachs Asset Management B.V. is unable to pay out ?

You may not face a financial loss due to the default of the Manufacturer. The assets of the Fund are held in safekeeping by its depositary, Brown Brothers Harriman (Luxembourg) S.C.A. (the "Depositary"). In the event of the insolvency of the Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations as set out in the agreement with the Depositary). Losses are not covered by an investor's compensation or guaranteed scheme.

## What are the costs ?

## Costs over Time

## How long should I hold it and can I take the money out early ?

Recommended holding period: 7 year(s).

This is not a recommendation to redeem your investment after this time and while longer holding periods allow greater time for the Fund to implement its strategy, the outcome of any holding period with respect to investment returns is not guaranteed. Investors may redeem their shares on any Business Day (as defined in the Prospectus) by giving prior written notice as further described in the Prospectus. Redeeming your shares in the Fund before the recommended holding period may be detrimental in terms of your return and may increase the risks associated with your investment, which may lead to the realisation of a loss.
