As noted in the table provided below, the Goldman Sachs Income Builder Fund made distributions for the month ended March 31, 2025, for which a portion is estimated to be in excess of the Fund's current net income as calculated in accordance with good accounting practice. The Fund's distributions normally consist of dividends and distributions received from master limited partnerships ("MLPs") and other portfolio securities. Historically, distributions received from MLPs include a return of capital for tax purposes. As a result, when the Fund pays these distributions to shareholders they may share a similar tax treatment. As of March 18, 2025, the estimated sources of these distributions were as follows:
