Market Review

The Russell 2000 Index finished the fourth quarter of 2024 slightly up, the index returned just 0.33% during the period. Small cap equities posted very strong returns in November, which worked to offset headwinds faced in the first and last months of the quarter. Significant equity market moves in November came on the back of the results of the US Presidential Election; investor optimism following the outcome fueled exuberance in more speculative areas of the market. However, the US equity rally was relatively short lived, reverting in mid-December after investors began to adjust their expectations of the future path of rate cuts on the back of more-hawkish-than-expected comments from the US Federal Reserve.

Performance Review

The **GS Small Cap Equity Insights Fund** (I-share, net) returned 0.43% in the fourth quarter of 2024, outperforming its benchmark, the Russell 2000 Index, by 10 basis points. Over the full year 2024, the Fund meaningfully outperformed its benchmark, outperforming the Russell 2000 Index by over 7.5% (I-share, net).

Our **Themes and Trends** pillar was the largest contributor to excess returns in the last quarter of the year. The bulk of the pillar's contributions to excess returns occurred in the latter two months of quarter. More specifically, our proprietary linkages signals worked in conjunction with our collection of industry momentum signals to contribute to positioning within the Financials and Industrials sectors.

Our **Sentiment Analysis** pillar also contributed to excess returns during 4Q24. Our suite of signals that seek to glean analyst sentiment using natural language processing techniques were especially effective during the period. These signals helped contribute to overweight positioning in select Industrials companies that participated in the post-election equities rally. Additionally, the pillar's collection of signals that aim to capture market sentiment also contributed to excess returns, contributions were more dispersed across sectors during the quarter.

Our **High-Quality Business Models** pillar was the lone detractor from relative performance through the reporting period. The pillar faced the majority of its challenges in the second month of the period, particularly in the weeks following the election. During this time, more volatile companies rallied, including unprofitable tech and bitcoin related names. The rally of 'lower quality' names presented a challenging environment for the pillar, whose underperformance was concentrated in the Information Technology sector.


Our **Fundamental Mispricings** pillar was flat during the quarter.




