

## 議決権行使結果の個別開示について

この度、日本版ステュワードシップ・コードの原則 5-3(抜粋)「機関投資家は、議決権の行使結果を、少なくとも議案の主な種類ごとに整理・集計して公表すべきである。また、機関投資家がステュワードシップ責任を果たすための方針に沿って適切に議決権行使をしているか否かについての可視性をさらに高める観点から、機関投資家は、議決権行使結果を、個別の投資先企業及び議案ごとに公表すべきである。」/「議決権の行使結果を公表する際、機関投資家が議決権行使の賛否の理由について対外的に明確に説明することも、可視性を高めることに資すると考えられる。特に、外観的に利益相反が疑われる議案や議決権行使の方針に照らして説明を要する判断を行った議案等、投資先企業との建設的な対話に資する観点から重要と判断される議案については、賛否を問わず、その理由を公表すべきである。」に則り、ゴールドマン・サックス・アセット・マネジメント(以下「GSAM」)は、GSAM における日本株式に関する議決権行使指図結果について個別に開示し、また一部の議案についてその議決権行使指図の判断理由を開示することとしました。
